Des says, "Our presence to date has been very noticeable and, as this is an election year, we must keep the issue of abortion in the public forum as best we can. I do not anticipate any change in the nature of our presence this year- that is, silent and low-key. I am hopeful that we can get a wider group of volunteers."

Zoe's Law – the pro-aborts are running scared!

AUSTRALIAN CATHOLIC YOUTH FESTIVAL

In December 2013, I attended the Australian Catholic Youth festival, with a particular interest in the events seeking to promote the culture of life. While most of the events were in some way directed towards positive cultural change, it was Anna Kohrn's talk 'Choosing Life' that caught my attention. Anna's talk emphasised

human dignity from conception all the way through to natural death. She placed euthanasia and abortion in the context of many other issues that threaten human dignity throughout many different stages of development.

Anna discussed issues such as eugenics, cosmetic surgery, euthanasia, IVF and abortion whilst emphasising that life issues are not exclusive but are all linked. We looked at cultural trends and attitudes which result in many groups of our society becoming vulnerable. She noted that as a culture, we are striving towards a superficial perfection, perfection dictated to us by the media.

Throughout her speech, it became evident that abortion and euthanasia were products of a self-focused culture. In the allconsuming quest to lengthen our life span and to look younger for longer, we neglect the less fortunate in Australia including the many indigenous Australians who live in third world conditions, the homeless and the unborn. While striving for the perfect image, we tend to cast aside all that we deem to be imperfect or anything that may hinder us from achieving our picture perfect lifestyle. In the midst of such attitudes children are becoming not a gift but a product; something to obtain or dispose of at our own convenience. While the reasons women may have an abortion vary greatly, the general pro-choice arguments are rooted in this individualistic consumerism. The slogan 'My body, my choice' does not encapsulate the inherit dignity of the mother or the unborn child but rather reduces the child to a mere burden whose existence is an infringement upon the women's liberty.

Anna spoke of the great irony of IVF: in order to achieve the good of a new baby we are prepared to throw out or indefinitely freeze countless numbers of embryos. Anna spoke of the millions of frozen embryo's worldwide, and the fact that we are prepared to dispose of life in the very attempt to create it. Unfortunately, IVF contributes to the attitude that a child is a product -a dangerous concept. If a child is to be viewed as a product to be purchased then so too can we dispose of it when we are unsatisfied with what we have received. Furthermore, the embryos that are not used by the parents die because they are not a part of the product ordered by the parents.

Through attending the conference, I was able to see that issues such as abortion and euthanasia are merely products of an

attitude present in almost all facets of society. Therefore it is important to use a diverse range of methods to defend life. In the past I have felt at loss when thinking of a way to defend the unborn however Anna's talk demonstrated that being pro-life is so much more than just being anti-abortion as she stated "Being Pro-Life means being concerned about all issues from bullying to genocide".

WARRNAMBOOL VOTERS INCENSED -

NAPTHINE'S MORAL FAILURE

Warrnambool prolife voters are incensed at a video released (3/12/13) by the Premier Denis Napthine, reinforcing the government's determination not to revisit the Abortion Law Reform Act 2008.

The Premier stated "Let me again be crystal clear about this: I have no intention what so ever of introducing or supporting legislation that would reduce a woman's right to choose... This issue was vigorously debated in the community and settled in the Parliament in 2008".

The video has incensed prolifers in his electorate who have reacted strongly to the message.

Aborting Responsibility



[This article is an abridged version of Puerile Politics, which was published on Mishka's blog, Eyes of the Mind, on 21/11/2013.]

The Tasmanian parliament has finally passed the *Reproductive Health* (Access to Terminations) Act 2013 after a drawn-out committee process and numerous amendments. The

original bill was highly flawed piece and raised serious concerns with regard to civil liberties and conscientious objection.

The revised legislation is an improvement, but it does not allay genuine (and reasonable) fears that it will be used to punish dissent more than than it will be used increase access to 'terminations'.

Doctors will remain complicit in the abortion process (if they obey the law). There will still be 300-metre-wide access zones with draconian penalties. Most importantly, from a moral perspective, it precludes women in Tasmania from ever being prosecuted for killing their unborn children while at the same time making protests near abortion clinics (including silent prayer vigils) a crime.

The nagging question at this time is how this could happen. I have a theory, but it doesn't have anything to do with women's rights, foetal development, or personhood. These are major discussion points, and the idea of women's rights exerts an incredible amount of pressure on us, but they have nothing to do with how some of us justify abortion.

I think our moral inconsistency about abortion is a result of our immaturity and fear of responsibility.

When we support (or fail to oppose) abortion, it isn't about the child. It's about our fear of being forced to grow up. When we think about an unplanned pregnancy we don't like the idea of 'forcing' someone to live with a situation for which they don't feel 'ready'. And this is something pro-lifers in particular need to understand. Pro-choicers are being compassionate – selectively compassionate, it is true, but compassionate nevertheless. They think about the mother (and sometimes the father) and say to themselves: *How could I force someone to have a child when they're not ready? I'm not ready. I wouldn't want a child right now. How could I do this to them?*

Of course, this is a childish way of thinking, but we all do it. The positive aspect is that we're putting ourselves in another person's shoes. The negative is that we're being uncharitable and assuming they're incapable of handling the situation. Realistically, we're all capable of taking care of a child, especially if it's our own and we have several months to prepare. History

shows us that we're capable of this even in the worst of circumstances.

It's our immaturity that makes abortion an option. It doesn't matter when we think the unborn child becomes a person because we're not actually thinking about the unborn child. We're thinking about ourselves and how this unexpected event will ruin all our plans. We have become control freaks who can't cope with the vagaries of life. Children are no longer considered a fact of life but an inconvenient burden. We resent anything that reminds us that we're not in control.

We will continue to see abortion as an option until we grow up and accept that when a woman falls pregnant her body is merely doing what it's designed to do. We can try to put it off by aborting the child, but we're only fooling ourselves. We can have another child later when we're 'ready' but it won't be the same child, it'll be another one. The aborted child is a unique individual who will never see the light of day. The child we have later, when we're 'ready', will have a different DNA and a different personality. It will be a different person.

I'm not suggesting that every pregnancy must be greeted with delight, but we certainly need to cultivate a positive attitude towards our offspring, whether planned or not. There's never a perfect time for having a child. None of us, even the ones trying to have a child, keep our schedules free in anticipation of a child. Few of us ever get to the point where we feel 'ready' for the sacrifice entailed in having children. But a mature adult can handle the unplanned in a responsible manner. A grown-up accepts the challenges of life and takes them on. Abortion is just one form of avoidance. It's our way of pretending the unexpected never happened. But it did. And that unexpected 'thing' was a child of one's own flesh and blood.

So it's time we behaved like adults, but that entails so much more than just taking responsibility. We also need to assign responsibility. In the context of Tasmania's abortion legislation, that means talking less about women's rights and more about parental responsibility. It means treating women as adults with moral agency and seeing them as capable. Women are not helpless frail creatures who are so pitifully incompetent that they can't carry a child to term and must be protected from criticism, not to mention the truth that abortion is homicide. And it means recognising that no one, not even an emotional and 'desperate' mother, has the right to kill her child.

RIGHT TO LIFE CAMPAIGN IN TASMANIA 2013

"Although we are based in Melbourne when we saw the horrendous nature of the Reproductive Health (Access to Terminations) Bill 2013, about to be inflicted on Tasmania's unborn, we knew we had to do our utmost to oppose it". Margaret Tighe

The following is account of our campaign by Mary Collier: The campaign against Reproductive Health (Access to Terminations) Bill 2013 was one of our strongest campaigns during 2013. Rep Bette Grande (prolife legislator in the State of North Dakota, USA) was visiting Australia on behalf of Right to Life Australia at the time that the Legislative Council was in Committee stage of debate. We arranged for Bette to give a presentation to politicians and the public at Parliament House in Tasmania. Bette also met politicians individually.

We published a number of advertisements in the Mercury and Launceston Examiner newspapers. One advertisement was refused because we listed the mobile numbers of politicians, however, we showed them that they had already published our advertisement a few months earlier with the mobile numbers printed. Indeed their mobile phone number was already on the Parliament of Tasmania website. It was then printed! The advertisement asked the public to phone their MP to express their views and ask him/her to vote NO!

Newspaper advertising is expensive-a half page colour advertisement in the Mercury costs \$988.00. One advertisement showed a photo of a baby in his father's arms with the caption: "This baby is protected by law, unlike the unborn who have no protection due to legalised abortion". We also placed advertisements in local newspapers if the MP was pro-abortion. Local supporters assisted us on identifying MPs to lobby. During the debate in Legislative Council we emailed individual MLCs to offer information that could assist, including asking Bette Grande, (now back in USA) to email them.

President of RTLA Margaret Tighe sent information to MPs including evidence of an increase in late term abortions in Victoria which have resulted from the Abortion Law Reform (ALRA 2008) and informed them that we lobbied in 9 marginal electorates where members voted for the ALRA 2008, in the last state Vic election 2010, and 7 out of 9 MPs lost their seats.

Tragically the bill passed both houses of Parliament, so now Tasmanians will be able to have their babies aborted up until birth, we will not be allowed to protest outside abortuaries and doctors and health professionals are compelled to help women access abortion. Truly- the blackest day in Tasmania since the Port Arthur massacre.

RUTH FORREST MLC– PROUD OF "WATER BIRTH TERMINATION"

Pro- abortion MP Ruth Forrest MLC, Independent Member for Murchison described her role in a "water birth termination" during the abortion debate in the Legislative Council in Tasmania in November 2013.

The passing of this Act, the Reproductive Health (Access to Terminations) Act 2013 now gives Tasmania the most extreme pro-abortion laws in the Western World.

Addressing the Legislative Council on 19 November 2014 in Tasmania, Ms Forrest (previously a midwife) was talking about a pregnant friend who was making a decision about having a termination. Ms Forrest addressed Parliament and said "It was the most difficult and toughest decision she (the woman) has ever made. This was a desperately wanted baby and she was faced with the most difficult decision of her whole life. She had one baby already 10 years older but I have photos of this beautiful water birth, holding this little baby in her hands and smiling. She was happy that she birthed her baby the way she wanted to".

It is inconceivable to think of what this "terminology" means, having never heard it described before. Try and google it.

TASMANIA - REPRODUCTIVE HEALTH (ACCESS TO TERMINATIONS) BILL 2013

The Reproductive Health (Access to Terminations) Bill 2013 was debated for six months until it was passed in November 2013 with a vote 9:5. This was a devastating setback for the Right to Life movement, for the unborn child, who can be killed right up to birth, without prosecution. Babies born alive after an abortion have no protection. The legislation also now suppresses any dissent against the abortion. A 300 metre "bubble zone" now surrounds abortion clinics in the state preventing all types of witness or protest. Even attempts by prolife MPs to reduce the number of weeks from 16 to 14 for the upper limit of weeks requiring two physicians' signatures were required, were blocked.

DR DEATH AND HIS SUICIDE SHOP!

Most of you will be aware South Australia has a state election on 15 March 2013. You will have also read in the Sunday Mail (17/11/13) or on internet or TV that Philip Nitschke has "opened" a euthanasia clinic in an Adelaide suburb. He apparently has raised money from supporters of "Exit International", his website. On his website he states "Learn about Max Dog Nitrogen, how

to obtain it, how to store it and use it in a way that will provide a peaceful, reliable, legal and totally undetectable death.

The clinic is located in a disused grocery shop in the suburb of Gilberton (post code 5081). Nitschke has already stocked it with helium canisters, nitrogen bottles and a laboratory used for

scientific testing. Drugs, imported from Mexico, China or Peru by prospective clients will be analysed by Nitschke in his laboratory – to ensure their purity in order to guarantee a peaceful and reliable death!

Nitschke is quoted as saying that "people are coming to me for social reasons, they are tired of life and want realistic choices. An elective peaceful, reliable death should be available for any adult of sound mind". Many groups are opposing the facility e. g. the Palliative Care Council of SA, anti-euthanasia group HOPE and of course Right to Life Australia Inc.

ELECTION IN TASMANIA – 15 MARCH 2013

On 15 March 2013 the Tasmanian state election will be held. In the past year there have been two bills introduced to Parliament which have threatened the sanctity of life in the state. The first was the Voluntary Assisted Dying Bill 2013 introduced by Labor Premier, Lara Giddings and Greens Party leader Nick McKim and was defeated 13-11 with Speaker Michael Polley effectively using his casting vote against it. This bill would have legalised both assisted suicide and euthanasia. Premier Giddings said on her website: "Who are we to say to an independent, competent adult that has voluntarily, persistently and consistently made a request for assistance to end their life that they must continue to live with pain and suffering, rather than allowing than allowing them to end their life at the time of their choosing?" Lara Giddings and Nick McKim also pushed the dreadful Abortion law along. Now you have an opportunity to remove these antilife politicians and have pro-life politicians represent you.

Encouraging arguments at U.S. Supreme Court in abortion clinic bubble zone case

The United States Supreme Court heard oral arguments in the case of McCullen v. Coakley, the Massachusetts "bubble zone" case. In 2007, the state enacted a law prohibiting speech within 35 feet of the entrance to an abortion facility, making sidewalk counselling at these facilities far more difficult. Sidewalk counsellor Eleanor McCullen, a 77-year old grandmother who has saved hundreds of babies with her peaceful outreach to women entering Massachusetts abortion clinics, challenged the law, saying it unfairly restricts her freedom of speech.

The transcript from Wednesday's hearing suggests that the Court is inclined to agree with her. Justices Kennedy, Scalia and Alito, in particular, challenged Massachusetts assistant attorney general Jennifer Miller on her daim that the law does not discriminate based on one's viewpoint.

America must ban sexselective abortions, or risk a China-like dearth of baby girls

January 20, 2014 (ThePublicDiscourse.com) - For more than thirty years, the Chinese government has been carrying out one of the most massive social experiments in human history. In order to head off what officials believed to be an unsustainable rate of population growth, it enacted, and has often brutally enforced, a one-child policy. While the policy has slowed population growth in China, the side effect has been the creation of an unprecedented gender imbalance

Ever since the early 1980s, when ultrasound examinations became widely available in China, the number of boy births per 100 girl births has soared. According to China's National Bureau of Statistics, it reached a peak of 120 in 2008. Although that number dropped to 117 in 2012, it still remains well above the normal range of 103 to 107.

The skewed gender ratio in China has created a generation of young men without hope of finding a mate. The social consequences of this phenomenon are just beginning to be realized. Columbia University economist Lena Edlund has estimated that for every 1 percent increase in the gender imbalance, there is a 6 percent increase in violent crime and property crime.
